MEDAL OF MERIT

The Medal of Merit is awarded to a person or persons for a particular contribution of outstanding value to the development or fostering of LORAN. This award is normally given only after the exceptional nature of the contribution is clearly recognized.

"The Medal of Merit of the Wild Goose Association is awarded to William L. Polhemus is recognition of his development and pomotion of Loran-C including innovative endeavors resulting in the adoption of Loran-C as the national navigation aid for the U.S. coastal confluence zone and the original incorporation of Loran-C into the National Airspace System.

Starting in 1968 after his retirement from the U.S. Air Force, he conducted definitive studie that supported a Congressional mandate designating Loran-C as this country's official marinnavigation aid in the coastal confluence region and established the analytical basis fo aviation applications. Later, he organized a federal-state-industry team that conducted etensivfield test and evaluation of Loran-C for airborne navigation. His participation in the progra as principal investigator was the key element in the FAA presentation of the first certificatauthorizing the use of Loran-C in the National Airspace System.

His enthusiasm for new applications and his dynamic advocacy have not diminished as evidenced by his tireless efforts to develop Loran-C approaches nationwide and his initiative to eplore the advantages of employing Loran-C and the Global Positioning System Interoperability.

The Wild Goose Association acknowledges with pride these important contributions and commitmen to the widespread use of Loran."

A draft Memorandum of Understanding (MOU) has been prepared between the FCC, the National Telecommunications and Information Administration (NTIA), the North American Electric Reliability Council (NERC) and the Utilities Telecommunications Council (UTC). UTC is acting on behalf of the power line carrier users.

The purpose of the MOU is to establish and maintain a transmission Power Line Carrier Data Base (PLCDB) and a Licensed User Data Base (LUDB), specifically covering operation in the 10-490 KHz band. NERC has been designated responsible for implementing the activity.

In the MOU, the paragraph titled "Availability of PLCDB Data" reads in part, ".... The PLC data provided by NERC to licensed users shall be released only to other licensed users or to their federally contracted supporting entities and shall be used only for spectrum management and coordination purposes. However, in the band 70-130 KHz, PLC user information may be released by the federal aencies to established LORAN-C user groups for the purpose of evaluating potential interference to the LORAN-C system. NERC will provide a set of microfiche of PLC user information in this band for this purpose."

This apparently means that some time in the future, data on PLC operation in the 70-130 KHz band will be available to obtain the data. Stay tuned.


